**A RESOLUTION OF THE MANTUA TOWNSHIP FIRE DISTRICT
NO. 1 BOARD OF FIRE COMMISSIONERS RE: SETTING THE
MEETING DATES AND TIMES FOR THE BOARD OF FIRE
COMMISSIONERS FOR THE 2016-2017 YEAR**

WHEREAS, Public law 1975, Chapter 231, Section 13, requires a public body to post and maintain posted, to distribute to designed newspapers, and to further file with the Municipal Clerk for the purpose of public inspections, a schedule of the regular meetings of such public body to be held during the calendar year; and

WHEREAS, such schedule of regular meetings is required to contain the location of each meeting, to the extent that it is known, and the time and date of each meeting; and,

WHEREAS, Public Law 1975, Chapter 231, Section 3-D, provides that where the annual notice or revisions thereof, in compliance with sections of the subject act, set forth the location, time and date of any meeting, no further action shall be required for such meeting.

NOW, THEREFORE BE IT RESOLVED, that the Board of Fire Commissioners of the Mantua Township Fire District No. 1, County of Gloucester, shall meet for its regular meeting at 7:00 PM on the third Thursday of each month during the calendar year 2016, and the first meetings of 2017 as indicated below.


