Board of Fire Commissioners
Minutes of Regular Meeting
April 19, 2018

Chairman K. Howarth called the meeting to order pursuant to the Open Public Meetings Act.

Consideration of Minutes from Previous Regular Meeting:

A Motion was made by Commissioner J. Hauss to approve the Minutes from the previous Regular Meeting. Second by Commissioner L. Campbell, motion passed unanimously.

Resolutions, Bids:

A bid was received for the repair to the basement of the Barnsboro Property at 721 Main Street.

Treasurer's Report:

Commissioner J. Hauss presented the Treasurer's Report.

Commissioner J. Hauss stated that there were 28 purchase orders totaling \$23,610.25 the payments over \$1,000.00 in this bill pay were for \$1,100.00 for Training to Burlington County, \$1,077.00 for Leather Boots to MES, \$1,243.94 for Hoods and Gloves from Witmer Public Safety, as well as, \$7,608.08 and \$7,851.77 to Payroll.

Commissioner J. Hauss then read the Current Bank Account Statements. Commissioner J. Hauss advised that General Disbursements - \$1,456,948.44 and Main Street Account - \$163,918.64.

Commissioner J. Hauss then spoke with the commissioners regarding an issue with the Fire District's former CFO. The fire district was not billed for liability and workman's compensation insurance for 2017 and we were recently billed for \$51,250.00.

Commissioner J. Hauss stated that he is waiting for a plan from the auditor make the payment.

A Motion was made by Commissioner L. Campbell to accept the Treasurer's Report and pay the bills (\$23,610.25). Second by Commissioner J. Hauss, motion passed unanimously.

Commissioners spoke about the issue at the Barnsboro Station at 721 Main Street. It was determined that a toilet on the main floor ran over night on April 18th to April 19th. During that time the toilet overflowed and leaked onto the floor and into the basement causing significant damage. It was recommended by Commissioner N. Vacarino that the tenants, True North Church, handle the water remediation and repair since the damage was caused by their issue. It was further discussed that the Fire District needed to repair the carpet in the basement regarding an upcoming French drain installation, so the fire district would incur the cost of the carpet repair.

A Motion was made by Commissioner L. Campbell to approve the Building Maintenance Report. Second by Commissioner J. Hauss, motion passed unanimously.

Vehicle Maintenance Report:

Captain D. Hauss presented the Vehicle Maintenance Report:

Captain D. Hauss stated that he is servicing apparatus and working on police cars. Police Cars are keeping him busy.

A Motion was made by Commissioner L. Campbell to approve the Building Maintenance Report. Second by Commissioner J. Hauss, motion passed unanimously.

Solicitors Report:

Chief B. Hauss advised that he emailed the Solicitor about meeting soon, and he advised that he cannot any of the upcoming meetings. The commissioners wanted to try and set up either a meeting or a conference call as soon as possible. Chief B. Hauss stated that he would contact the solicitor on April 20th to try and set up some dates.

New Business:

Commissioner N. Vacarino read the above mentioned bid from Support works by Dry Guys. Commissioner N. Vacarino read the detailed bid, for \$3,696.49. Commissioner N. Vacarino requested that Chief B. Hauss look into two more quotes for the same repairs. No further business was discussed.

Old Business:

Commissioner N. Vacarino spoke about the Jackson Road Roof Project. The roof project began on Wednesday, April 18th and at the time of the meeting the work appeared to be good. He also mentioned that the plywood looked clean, and that the roof vents were actually included in the initial proposal. Commissioner N. Vacarino stated that he was happy with the work so far. The job will be completed on Friday, April 20th. The signed proposal was turned over to Chief B. Hauss and logged with the remainder of the proposals.

Commissioner L. Campbell advised that at the last meeting the PBA president stated that their current landlord is fine with them leaving and that they hope to be moving in by June 2018.

Open Meeting to Public:

There was a motion by Commissioner L. Campbell to open the meeting to the public. Second by Commissioner J. Hauss, motion passed unanimously.

Motion to Close Public Portion:

Mr. Sidney Marks of 143 Ferndale Avenue stated that the applications for the National Fire Academy are due by Monday, April 23rd.

Captain N. Lamana asked about the status of the sign for the front of Union Avenue Station.

Chief B. Hauss advised that he spoke with BHR Contracting about the sign and that he has an idea to install the sign. Commissioners advised to inquire about pricing for BHR Contracting to complete the project.

There being no further comments the Public Portion of the Meeting was closed on Motion by Commissioner L. Campbell. Second by Commissioner J. Hauss, motion passed unanimously.

Motion to Adjourn:

Commissioner J. Hauss thanked the members for their good work on a recent motor vehicle crash on Lambs Road.

Commissioner L. Campbell made a motion to adjourn, second by Commissioner J. Hauss, motion passed unanimously.
