Vacarino stated that an average gas and electric bill was provided to Covenant Messiah Church and that they are responsible for any bills over average utility bills.

Commissioner N. Vacarino then asked about the status of the shared services agreement with West Deptford, Commissioner J. Hauss advised that the agreement is on stand by awaiting approval by West Deptford town council.
