Paid Position of Deputy Chief/Mechanic

WHEREAS, there exists a need within Fire District #1 in the Township of Mantua, County of Gloucester, to create paid position entitled Deputy Chief/Mechanic to perform duties as necessary: and

WHEREAS, the Commissioners of Fire District No. 1 in the Township of Mantua, County of Gloucester have determined that they are desirous of maintaining said positions.

NOW, THEREFORE, be it RESOLVED by the Commissioners of Fire District No. 1 in the Township of Mantua, County of Gloucester, as follows:


- (1) The Position of Deputy Chief/Mechanic is established.**
- (2) The annual salary is agreed upon in the attached Memorandum of Understanding and terms and conditions of employment for this position shall be as determined by the Commissioners and as otherwise mandated by New Jersey statutory law.**
- (3) The Position of Deputy Chief/Mechanic shall undertake any and all responsibilities and administrative obligations relative to the fire district, as determined necessary by the Fire Commissioners.**
- (4) The Position of Deputy Chief/Mechanic shall be under the supervision of the Commissioners as designated by the Commissioners pursuant to N.J.S.A. 40:a:14-81.3.**
- (5) This resolution shall take effect following final adoption and publication pursuant to New Jersey statutory law.**

THIS RESOLUTION IS DULY ADOPTED at the Reorganization Meeting of the Mantua Township Fire District #1 Fire Commissioners held on January 2, 2020.
