WHEREAS, Pension Services can be performed by the Mantua Township Fire District


WHEREAS, an agreement has been negotiated in this regard and the terms and conditions of the agreement are in the best interest of the Fire District.

**TOWNSHIP OF MANTUA

**A RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT WITH THE  
MANTUA TOWNSHIP FIRE DISTRICT TO PROVIDE FOR THE ADMINISTRATION  
OF PENSION PAYMENTS**

**WHEREAS**, the Mantua Township Fire District is in need of personnel to administer the and process their Pension payments for the district employees, and

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A: 65-1, et seq. , (the "Act" ) permits units of local government to share services for particular purposes and to effectuate agreements for any service or circumstance that will aid and encourage a reduction of local expenses; and

**WHEREAS**, the Township of Mantua and Mantua Fire District are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey Law to enter into a Shared Services Agreement pursuant to the Act; and

**WHEREAS**, the Mantua Fire District and the Township have negotiated the terms of a Shared Service Agreement, included as EXHIBIT A and incorporated into this resolution as if set forth at length herein; and

**WHEREAS**, the Administrator has recommended the proposed agreement as representing the best value for Mantua taxpayers; and

**WHEREAS**, the Township Committee has indicated its desire to accept the recommendation of the Administrator, and;

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Township Committee of the Township of Mantua as follows:

1. The above recitals are hereby incorporated into the body of this Resolution as if set forth at length herein.
2. The Shared Services Agreement shall be open to public inspection in the Clerk's office and shall take effect upon the adoption of a resolution and execution of the agreement by both parties.
3. The Mayor and Township Clerk are hereby authorized to execute a Shared Services Agreement, the terms of which are annexed hereto as EXHIBIT A.

4. A copy of the Shared Services agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs.



**INTERLOCAL AGREEMENT BETWEEN THE TOWNSHIP OF MANTUA AND THE  
MANTUA TOWNSHIP FIRE DISTRICT**

**THIS AGREEMENT**, made this 6 day of Jan, 2020 by and between:

**MANTUA FIRE DISTRICT NO. 1** in the Township of Mantua, County of Gloucester and State of New Jersey. (hereinafter referred to as the "District") and **MANTUA TOWNSHIP**, County of Gloucester and State of New Jersey, (hereinafter referred to as the "Township").

**WHEREAS**, the District deems it necessary to secure assistance in providing services concerning the processing, administration and payment of their Pension costs; and;

**WHEREAS** the Township through its Chief Financial Officer, Gayle Tschopp, is able to provide these services to the District, and;

**WHEREAS**; the District and Township have reached an agreement relative to the providing of these services and the terms and conditions relative to same; and into.


**WHEREAS**, it is in the best interest of the public that such an agreement be entered into.

**NOW THEREFORE**, in consideration for the foregoing recitations and the mutual covenants and promises hereinafter contained, the parties hereby agree as follows:

- (1) The Township shall provide on behalf of the District the necessary employee and shall agree upon the specific procedures to enact the providing of these services.
- (2) The Township shall submit a voucher to the District for a total payment of of \$1,041.00 for the service.
- (3) This agreement shall be deemed effective after approval by Resolution by each of the entities and shall have a term of January 1, 2020 to December 31, 2020. It shall be automatically renewable and/or continued during its designated terms unless terminated by either entity upon 60 days written notice.
- (4) The terms and conditions set forth represent the entirety of the agreement between the parties.


